This indenture, made on this 5th day of June, 1907, by and between Harry M. Mitchell, of Vinita, Indian Territory, Party of the first part, and William H. Mitchell, of Seneca, Missouri, Party of the second part,

Witnesseth: That the party of the first part has acquired conveyances from allottees and the grantees of allottees of interests in lands on the Cherokee Nation as follows:
