This indenture, made this fifth day of June 1907, between Isaac Statcher, as Trustee, of Emporia in Lyon County, in the State of Kansas, of the first part, and R. C. Rawlings of Kansas County, in the State of Kansas, of the second part:

Witnesseth, that said party of the first part, in consideration of the sum of One and ⁰⁰/₁₀₀ Dollars, the receipt of which is hereby acknowledged, sold by these presents, Remise, Release and Quit-claim, unto said party of the second part, his heirs and assigns, all the following-described Real Estate, situated in the Cherokee Nation, and within the limits of the Northern District, Indian Territory, to-wit: the north one half of the north East quarter of the Northwest quarter (NW ¹/₄ NE ¹/₄ NW ¹/₄) and the South East quarter of the North East quarter of the Northwest quarter (SE ¹/₄ NE ¹/₄ NW ¹/₄) and North East quarter of the South East quarter of the Northwest quarter (NE ¹/₄ SE ¹/₄ NW ¹/₄) all of Section Nine (9) Township Twenty Three (23) North & Range Tenth (14) East.

Also the North East quarter of the South East quarter of the South West quarter (NE ¹/₄ SE ¹/₄ SW ¹/₄) of Section Twenty six (26) and South west quarter of the South west quarter of the South East quarter (SW ¹/₄ SW ¹/₄ SE ¹/₄) of Section Twenty six (26) and the North East quarter of the North East quarter of the North West quarter (NE ¹/₄ NE ¹/₄ NW ¹/₄) of Section Thirty six (36) of Township Twenty Two (22) North and Range Tenth (15) East of the 6th principal meridian and containing in the aggregate seventy (70) acres more or less.

To Have and to Hold the same, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, forever.
