

General Warranty Deed.

This Indenture, Made and entered into this 5th day of July, one thousand nine hundred and seven by and between Joseph Jacob single and Ed. Bucher of Muskogee part 7 of the first part, and C. S. Bucher of Muskogee part 7 of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of Five Hundred Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part 7 of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit:

The south east quarter of Section two (2) township ten (10) north range sixteen (16) east (and north west quarter of Section two (2) and south west of said west quarter Section One (1) all in Township nineteen (19) north Range Fourteen (14) east

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Ed. Bucher wife of the said Joseph Jacob for and in consideration of the said sum of money, do hereby release and relinquish unto the said part 7 of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part 7 of the second part, his heirs, executors, administrators and assigns forever.
