General Warranty Deed.

**Witnesseth**, That the said party ies of the first part, for and in consideration of the sum of Seven Thousand and Fifty Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party y of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: The North East Quarter of the North West Quarter of Section Twelve (12), Township Eighteen (18) North, Range Fourteen (14) East

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Alice Haymes wife of the said Frank L. Haymes for and in consideration of the said sum of money, do hereby release and relinquish unto the said party y of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party y of the second part, his heirs, executors, administrators and assigns forever.
