Witnesseth, That the said party ~~is~~ of the first part, for and in consideration of the sum of Seven Hundred Twenty-Five Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part, the following described real estate and premises situate in the Oreek Nation, and within the limits of the Indian Territory, to-wit: The North East Quarter of the North West Quarter of Section Twelve (12), Township Eighteen (18) North and Range Fourteen (14) East

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Niecey Johnson wife of the said Isaac F. Johnson for and in consideration of the said sum of money, do hereby release and relinquish unto the said part y of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part y of the second part, his heirs, executors, administrators and assigns forever.
