

General Warranty Deed.

This Indenture, Made and entered into this 15th day of Aug., one thousand nine hundred and seven by and between Lella H. Harrison and Mike Harrison her husband of Muskogee Co. parties of the first part, and Commonwealth Trust Co. of Muskogee Co. party of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of one hundred + twenty five dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part, the following described real estate and premises situated in the Nation, and within the limits of the Indian Territory, to-wit: South East quarter of the North West quarter and the Northeast quarter of the South West quarter of the Northwest quarter of sec. Thirty-two (32), Township Twenty-one (21), North Range Thirteen (13) East and being fifty acres allotted to Lella Harrison

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mike Harrison husband wife of the said Lella Harrison for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of country dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, issue heirs, executors, administrators and assigns forever.
