# General Warranty Deed.

This Indenture, Made and entered into this 19<sup>th</sup> day of August, one thousand nine hundred and seven by and between Gussie Burgess and a single man of Broken Arrow part y of the first part, and Harve L. Hollingsworth of Broken Arrow, part y of the second part.

Witnesseth, That the said party y of the first part, for and in consideration of the sum of (1800.00) Eighteen Hundred Dollars in hand paid, the receipt of which is hereby acknowledged, do is hereby grant, bargain, sell, convey and confirm unto said part y of the second part, the following described real estate and premises situate in the LeFlore Nation, and within the limits of the Indian Territory, to-wit: The East Half of the Northwest Quarter of Section Thirty-two (32) Township Eighteen (18) North, Range Fourteen East, containing Eighty (80) acres more or less

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Harve L. Hollingsworth wife of the said Gussie Burgess for and in consideration of the said sum of money, do hereby release and relinquish unto the said part y of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part y of the second part, his heirs, executors, administrators and assigns forever.
