COMPARED

This Indenture, Made and entered into this seventh day of September one thousand nine hundred and seven by and between Virey Grayson single and of Muskogee part y of the first part, and P. E. Heckman of Muskogee part y of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of Twenty-four Hundred Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part y of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit:

The east half (1/2) of the south east quarter (1/4) of the north west quarter (1/4) of the south east quarter (1/4) of section eight (8) township nineteen (19) north and Range (14) fourteen east containing 12.0 acres.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And she wife of the said for and in consideration of the said sum of money, do hereby release and relinquish unto the said part y of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part y of the second part, his heirs, executors, administrators and assigns forever.
