General Warranty Deed.

This Indenture, Made and entered into this 17th day of September one thousand nine hundred and Seven by and between Mary Mitchell and J. C. Drully of Nealaka T. part y. of the first part, and Haskell T. part y. of the second part.

Witnesseth, That the said party y. of the first part, for and in consideration of the sum of Twelve Hundred Fifty Dollars in hand paid, the receipt of which is hereby acknowledged, do Es. hereby grant, bargain, sell, convey and confirm unto said part y. of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: The south half of the south-east quarter of section fifteen (15) township eighteen (18), north Range thirteen (13) east of the Indian Meridian

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, J. C. Drully wife of the said Haskell T. for and in consideration of the said sum of money, do hereby release and relinquish unto the said part y. of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part y. of the second part, his heirs, executors, administrators and assigns forever.
