General Warranty Deed.

This Indenture, Made and entered into this 7th day of Oct, one thousand nine hundred and seven by and between Johnanna Shell and a single woman of Cherokee Co part y of the first part, and Robert B. Baird and G. B. Garstophen of Muskogee Co part y of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of Two Hundred and Forty Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part y of the second part, the following described real estate and premises situate in the Cherokee Nation, and within the limits of the Indian Territory, to-wit: The south east-quarter (1/4) of the south-west quarter (1/4) of Section nine (9) Township twenty three (23), north Range thirteen (13), east and north half (1/2) of north-west quarter (1/4) of north east-quarter (1/4) and south west-quarter (1/4) of north west quarter (1/4) of north-east quarter (1/4) and north west-quarter (1/4) of south-west quarter (1/4) of north east quarter (1/4) all in Section Sixteen (16) Township twenty three (23) north Range thirteen (13) east and containing eighty acres in all.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Wife of the said for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part y of the second part, his heirs, executors, administrators and assigns forever.
