This Indenture, Made and entered into this 4th day of October, one thousand nine hundred and seven by and between B. F. Waterson and Ora B. Waterson, his wife of Bishop, Ind. I part of the first part, and Patrick Fitzgerald of Bishop, Ind. I part of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of Seven Hundred fifty (\$750.00) Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: Lots numbered Six (6) Seven (7), Eight (8) Nine (9) and Ten (10), and Black numbered Twenty four (24) in the Midland addition to the town of Bishop, Indian Territory according to the plat of said town.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Ora B. Waterson wife of the said B. F. Waterson for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part of the second part, his heirs, executors, administrators and assigns forever.
