This Indenture, Made and entered into this twenty fourth day of October, one thousand nine hundred and seventy and between Robert A. Crowell and Omelia K. Crowell of Lawton, Ok parties of the first part, and J. B. Wilson a single man of Fort Smith, Ark party of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of \$7800.00 forty eight hundred dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: North one half and the south west one fourth of the north west quarter of Section Twenty (20) Township Thirteen (13) North Range Thirteen (13) East, con- taining one hundred and twenty (20) acres more or less as the case may be, according to the United States Geological Survey.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Omelia K. Crowell wife of the said Robert A. Crowell for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, his heirs, executors, administrators and assigns forever.
