

General Warranty Deed.

This Indenture, Made and entered into this 2nd day of November, one thousand nine hundred and seven by and between Fred Bukey and Mattie Bukey of Broken Arrow part of of the first part, and F. S. Hurd of Broken Arrow part of of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of One Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: The south half of the north west quarter of section nineteen in Township eighteen north and range fourteen east of the Indian Base and Meridian in Indian Territory

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mattie Bukey wife of the said Fred Bukey for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, his heirs, executors, administrators and assigns forever.
