

# General Warranty Deed.

This Indenture, Made and entered into this 6<sup>th</sup> day of November, one thousand nine hundred and ~~nine~~ by and between Mollie Wright and William W. Wright her husband of Barren Indiana parties of the first part, and William C. Rogers of Indian Indiana part of the second part.

Witnesseth, That the said parties of the first part, for and in consideration of the sum of One Hundred (\$100.00) dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part, the following described real estate and premises situate in the Cherokee Nation, and within the limits of the Indian Territory, to-wit: The SE 1/4 of SE 1/4 of Section 11, township 22 north Range 12 east of the Indian Base and Meridian containing 10 acres more or less the restrictions upon the sale of which have been removed by the Secretary of the Interior

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, William W. Wright husband wife of the said Mollie Wright for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, his heirs, executors, administrators and assigns forever.
