General Warranty Deed.

**This Indenture**, Made and entered into this 6<sup>th</sup> day of November, one thousand nine hundred and ~~sum~~ by and between William W. Wright and Mollie Wright his wife of Barren ~~parties~~ of the first part, and William C. Rogers of Kiaskia ~~parties~~ of the second part.

**Witnesseth**, That the said party of the first part, for and in consideration of the sum of One Hundred and 25/100 (\$100.25) Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said party of the second part, the following described real estate and premises situate in the Cherokee Nation, and within the limits of the Indian Territory, to-wit:

Lot 1, of section 14, Township 22, north Range 12 east of the Indian Base and Meridian containing 7.02 acres more or less, the restrictions upon the sale of which have been removed by the Secretary of the Interior.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Mollie Wright wife of the said William W. Wright for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, his heirs, executors, administrators and assigns forever.
