This Indenture, Made and entered into this 23rd day of November, one thousand nine hundred and seven by and between Sallie Morrison and Henry Morrison of Broken Arrow Okla part 2 of the first part, and Henry Morrison of Broken Arrow Okla part 2 of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of \$1,000 one thousand Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part, the following described real estate and premises situate in the Sevier County Nation, and within the limits of the State of Oklahoma Indian Territory, to-wit:

The South West quarter of the North West quarter of section thirty five 35th Township eighteen 18th N. Range thirteen 13th E.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Sallie Morrison wife of the said Henry Morrison for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part of the second part, his heirs, executors, administrators and assigns forever.
