

# General Warranty Deed.

This Indenture, Made and entered into this 9<sup>th</sup> day of August, one thousand nine hundred and seven by and between James A. Pemberton and wife Edith Pemberton of Stidham I.T. parties of the first part, and J. B. Smock or Eufaula I.T. part y of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of Twenty one hundred Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part y of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: E. 1/2 of S. E. 1/4 of Sec 17, and the N. W. 1/4 of S. E. 1/4 of Sec 17, Township 16 N. Range 13 East containing 120 acres more or less

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Edith Pemberton wife of the said James A. Pemberton for and in consideration of the said sum of money, do hereby release and relinquish unto the said part y of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part y of the second part, his heirs, executors, administrators and assigns forever.
