

# General Warranty Deed.

This Indenture, Made and entered into this 9<sup>th</sup> day of July, one thousand nine hundred and seven by and between D. S. Hurd and Nancy Hurd of Broken Arrow, I. T. parties of the first part, and George Barnard of Broken Arrow I. T. part 2<sup>d</sup> of the second part.

Witnesseth, That the said parties of the first part, for and in consideration of the sum of Two hundred \$ Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part 2<sup>d</sup> of the second part, the following described real estate and premises situate in the Creek Nation, and within the limits of the Indian Territory, to-wit: Lot number nineteen and twenty in Block number nineteen in North Side Addition to the town of Broken Arrow, Indian Territory.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same.

And I, Nancy Hurd wife of the said D. S. Hurd for and in consideration of the said sum of money, do hereby release and relinquish unto the said part 2<sup>d</sup> of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said part 2<sup>d</sup> of the second part, his heirs, executors, administrators and assigns forever.
