**This Indenture**, Made and entered into this 21st day of August, one thousand nine hundred and seven by and between Robert T. Barker and Alice A. Barker his wife of Marion, I.T. part of the first part, and Mrs. Mary Myrtle Stewart of Marion, I.T. part of the second part.

**Witnesseth**, That the said parties of the first part, for and in consideration of the sum of one thousand Dollars in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto said part of the second part, the following described real estate and premises situate in the Arceuth Nation, and within the limits of the Indian Territory, to-wit: The South (1/2) one half of the southeast (1/4) quarter of section (22) township two, in township (17) seventeen north, range (12) twelve east of the Indian Base and meridian containing Eighty acres, be it more or less, according to the Government survey thereof.

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in any wise appertaining, and warrant the title to the same, subject however to any and all claims or liens in said premises however and in what manner or under what title or claim is transferred with said land.  
And I, Alice A. Barker wife of the said Robert T. Barker for and in consideration of the said sum of money, do hereby release and relinquish unto the said part of the second part all my right of dower and homestead in and to said lands.

To have and to hold the said lands unto the said party of the second part, her heirs, executors, administrators and assigns forever.
