KNOW ALL MEN BY THESE PRESENTS:

That we *Gabriel Emartela* and *Hattie Emartela* his wife, for and in consideration of the sum of *Three Hundred & no*

DOLLARS, *one* *in hand* paid by *William M. Fawell* the receipt of which is hereby acknowledged do hereby grant, bargain, sell and convey unto the said *William M. Fawell* and unto *his* heirs and assigns forever, the following lands lying in the *Creek Nation* Western District of the Indian Territory, to-wit: *all of my entire undivided interest* *to the south half of the north east quarter* *and the north west quarter of the north east quarter of Section Twenty two (22) and the south half of the south east quarter and the north west quarter of the south east quarter of Section Twenty one (21) Township (19) north Range Thirtieth east the same being a portion of the* *To have and to hold the same unto the said William M. Fawell and unto his*

heirs and assigns forever, with all the appurtenances thereunto belonging. And hereby covenant with said *William M. Fawell* that *I* will forever warrant and defend the title of said lands against all claims whatever.

And I, *Hattie Emartela* wife of the said *Gabriel Emartela* for and in consideration of the said sum of money, do hereby release and relinquish unto the said *William M. Fawell* all my rights of dower and homestead in and to the said lands.
