And hereby covenant, with said J. J. Baumann and W. E. Rhode that they
 will forever warrant and defend the title of said lands against all claims whatever.

 for and in consideration of the said sum of money, do hereby release and relinquish unto the said

J. J. Baumann and W. E. Rhode all my rights of dower and homestead in and to the said lands.
