WARRANTY DEED #5507

WITH RELINQUISHMENT OF DOWER.
WESTERN JUDICIAL DISTRICT, INDIAN TERRITORY. OFFICIAL FORM

KNOW ALL MEN BY THESE PRESENTS:

That we *Sam Company* and *Ind. Ter.*
his wife, for and in consideration of the sum of *One dollar and other valuable consideration*
DOLLARS, to me paid by *Bradley Realty Bank and Trust Company*
receipt whereof is hereby acknowledged

do hereby grant, bargain, sell and convey unto the said *Bradley Realty Bank and Trust Company*
its successors *and assigns* forever, the following lands lying in the *Western District of the Indian Territory*, to-wit:
The North Half of the North West quarter of Section Thirty Two (32) and East Half of the North East quarter of Section Thirty One (31) Township Nineteen (19) North and Range Twelve (12) East, less the homestead

To have and to hold the same unto the said *Bradley Realty Bank and Trust Company* and unto
its successors *heirs and assigns* forever, with all the appurtenances thereunto belonging.
Sam Company And hereby covenant with said *Bradley Realty Bank and Trust Company* that said lands
are free from all incumbrances, that
will forever warrant and defend the title of said lands against all claims whatever.

And I, *Sam Company* wife of the said *Sam Company*
for and in consideration of the said sum of money, do hereby release and relinquish unto the said *Bradley Realty Bank and Trust Company*
all my rights of dower and homestead in and to the said lands.
