KNOW ALL MEN BY THESE PRESENTS.

That we John O Mitchell and Alice M Mitchell
his wife, for and in consideration of the sum of Three Hundred sixty two & 50/100 DOLLARS,
in hand paid the receipt of which is hereby acknowledged

do hereby grant,
bargain, sell and convey unto said Dickason Goodman Lumber Co. and unto its heirs and assigns forever, the following
lands lying in the Creek Nation Western District of the Indian Territory, to-wit:

All of lots Thirteen (13) fourteen (14) and fifteen (15) Block eleven (11) West-Tulsa Addition Creek Nation Indian Territory according to recorded plat thereof.

TO HAVE AND TO HOLD the same unto the said Dickason Goodman Lumber Co. and unto its heirs and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said Dickason Goodman Lumber Co. that we will forever warrant and defend the title of said lands against all claims whatever.

And I, Alice M Mitchell wife of the said John O Mitchell for and in consideration of the said sum of money, do hereby release and relinquish unto the said Dickason Goodman Lumber Co. all right of dower and homestead in and to said lands.
