**WARRANTY DEED**  
WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we J. D. Hagler and Margaret Hagler  
his wife, for and in consideration of the sum of One Thousand DOLLARS,  
In hand paid by Martin Kelley, receipt of which is hereby acknowledged  
and confessed do hereby grant,  
bargain, sell and convey unto said Martin Kelley and unto his heirs and assigns forever, the following  
lands lying in the City of Tulsa Western District of the Indian Territory, to-wit:  
Lot Seven (1) Block Two (2) in Bliss Addition to the City  
of Tulsa, Indian Territory, according to the recorded plat thereof.

TO HAVE AND TO HOLD the same unto the said Martin Kelley and unto his heirs  
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said Martin Kelley that we will forever warrant and de-  
fend the title of said lands against all claims whatever.

And I, Margaret Hagler, wife of the said J. D. Hagler for and in consideration of the said sum of  
money, do hereby release and relinquish unto the said Martin Kelley my all right of dower and homestead in and to said lands.
