OFFICIAL FORMWARRANTY DEED
WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we S. H. Williams and Bessie L. Williams
his wife, for and in consideration of the sum of Twelve 50 75 DOLLARS,
to us paid by P. A. Huddleton

do hereby grant,
bargain, sell and convey unto said P. A. Huddleton and unto his heirs and assigns forever, the following

lands lying in the N.E. 1/4 of the NW 1/4 Western District of the Indian Territory, to-wit:
and the West half (shown on the U.S. Survey as lots 1 & 2) of
the NW 1/4 of Sec. 31, T. 19 N and Range 14 E, Creek Nation Western
District of the Indian Territory, to-wit:
Lot 9 NW. Nine Block 10 NW. Ten

TO HAVE AND TO HOLD the same unto the said P. A. Huddleton and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And, hereby covenant with said P. A. Huddleton that we will forever warrant and de-
fend the title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. H. Williams for and in consideration of the said sum of
money, do hereby release and relinquish unto the said P. A. Huddleton all right of dower and homestead in and to said lands.
