WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we S. K. Williams and Bessie L. Williams
his wife, for and in consideration of the sum of Twelve 50/100 DOLLARS,
to us paid by Emma Swape

do hereby grant,
bargain, sell and convey unto said Emma Swape and unto her heirs and assigns forever, the following
lands lying in the N. E. 1/4 of the N. W. 1/4 Western District of the Indian Territory, to-wit:

and the west half shown on the U. S. Survey, as Lots 1 & 2 of
the N. W. 1/4 of Sec. 3, T. 19 N. and Range 14 E Creek Nation
western District of the Indian Territory, to-wit:
Lot 12 N. Twelve Block 23 N. Twenty Three in Valley
ET.

TO HAVE AND TO HOLD the same unto the said Emma Swape and unto her heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said Emma Swape that we will forever warrant and de-
fend the title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. K. Williams for and in consideration of the said sum of
money, do hereby release and relinquish unto the said Emma Swape all right of dower and homestead in and to said lands.
