WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we S. R. Williams and Bessie L. Williams
his wife, for and in consideration of the sum of Twenty Five DOLLARS,
to us paid by William Sawyers

do hereby grant,
bargain, sell and convey unto said Wm Sawyers and unto his heirs and assigns forever, the following

lands lying in the NE 1/4 of the NW 1/4 Western District of the Indian Territory, to-wit:
and the West half (shown on the U. S. Survey as lots 1 & 2) of the NW 1/4
of Sec 31, T. 19 N and Range 14 E, Creek Nation, Western District
of the Indian Territory, to-wit:

Lot 6 NW 1/4, Sec 31, Block 27, T. 19 N, R. 14 E, Creek Nation, Western District

in Valley St. Wm Sawyers

TO HAVE AND TO HOLD the same unto the said Wm Sawyers and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said Wm Sawyers that we will forever warrant and de-
fend the title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. R. Williams for and in consideration of the said sum of
money, do hereby release and relinquish unto the said Wm Sawyers all right of dower and homestead in and to said lands.
