WARRANTY DEED
WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we C. B. Lynch and Jay Forsythe and E. J. Lynch and Jennie Forsythe their
wives for and in consideration of the sum of Seven Hundred (\$700.00) DOLLARS,
the receipt of which is hereby acknowledged in full.

do hereby grant,
bargain, sell and convey unto said B. C. Bean and unto his heirs and assigns forever, the following
lands lying in the Creek Nation Western District of the Indian Territory, to-wit:

Lots Three & Four (3 & 4) Block nine C9 Lynch & Forsythe
addition to Tulsa, Ind. Ter.

TO HAVE AND TO HOLD the same unto the said B. C. Bean and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant S with said B. C. Bean that they will forever warrant and de-
fend the title of said lands against all claims whatever. It being agreed by B. C. Bean in the acceptance
of this deed that there is to be no drilling for oil or gas on above lots.

And Mr. E. J. Lynch and Jennie, wife of the said C. B. Lynch and Jay Forsythe for and in consideration of the said sum of
money, do hereby release and relinquish unto the said B. C. Bean all right of dower and homestead in and to said lands.
