bargain, sell and convey unto said Minnie Page and unto her heirs and assigns forever, the following
lands lying in the Western District of the Indian Territory, to-wit:SW 1/4 of the NW 1/4 and the West Half (shown on the U. S.
Survey as lots 142, 143, 144 of the NW 1/4 of Sec. 31 T. 19 N. and
Range 14 E. Creek Nation Western District of the Indian
Territory, to-wit: Lot 20 no. County Block 13 no. 1000
in Valley S. T.TO HAVE AND TO HOLD the same unto the said Minnie Page and unto her heirs
and assigns forever, with all appurtenances thereunto belonging.And hereby covenant with said Minnie Page that we will forever warrant and de-
fend the title of said lands against all claims whatever.And I, Berie L. Williams, wife of the said S. K. Williams for and in consideration of the said sum of
