# WARRANTY DEED WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we B. H. Sands and Ethel M. Sands  
his wife, for and in consideration of the sum of Four hundred fifty \$ \$ \$ DOLLARS,  
receipt of which is hereby acknowledged

do hereby grant;  
bargain, sell and convey unto said Margaret M. and Mabel A. Wies and unto their heirs and assigns forever, the following  
lands lying in the Creek Nation Western District of the Indian Territory, to-wit:

all of lots three (3) and four (4) in Block six (6) in Okmulgee  
Suburb to Tulsa, Creek Nation, Indian Territory, according  
to the recorded plat thereof.

TO HAVE AND TO HOLD the same unto the said Margaret M. and Mabel A. Wies and unto their heirs  
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said Margaret M. and Mabel A. Wies that they will forever warrant and de-  
fend the title of said lands against all claims whatever.

And I, Ethel M. Sands, wife of the said B. H. Sands for and in consideration of the said sum of  
money, do hereby release and relinquish unto the said Margaret M. and Mabel A. Wies all right of dower and homestead in and to said lands.
