**WARRANTY DEED
WITH RELINQUISHMENT OF DOWER.**

KNOW ALL MEN BY THESE PRESENTS.

That we S. K. Williams and Bessie L. Williams
his wife, for and in consideration of the sum of Twelve ⁵⁰⁰ DOLLARS,
one paid by W. M. Hatfield,

do hereby grant,
bargain, sell and convey unto ^{the} said W. M. Hatfield and unto his heirs and assigns forever, the following
lands lying in the Western District of the Indian Territory, to-wit:

142) of the NW 1/4 of sec. 31, T. 19 N. and range 14 E Creek Nation,
Western District of the Indian Territory town of
Lot 15 no. fifteen Block 5 m. j. in Valley T. T.

TO HAVE AND TO HOLD the same unto the said W. M. Hatfield and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And ^{we} hereby covenant with said W. M. Hatfield that we will forever warrant and de-
fend the title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. K. Williams for and in consideration of the said sum of
money, do hereby release and relinquish unto the said W. M. Hatfield ^{my} all right of dower and homestead in and to ^{the} said lands.
