**WARRANTY DEED**  
WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we John O. Mitchell and Alice M. Mitchell  
his wife, for and in consideration of the sum of Sixty five DOLLARS,  
25 is in hand paid by A. P. Cooper the receipt of which  
is hereby acknowledged do hereby grant,  
bargain, sell and convey unto said A. P. Cooper and unto his heirs and assigns forever, the following  
lands lying in the town of West Tulsa Creek Western District of the Indian Territory, to-wit:  
all of lots number four (4) in Block number  
twenty four (24) situated in West Tulsa Creek nation  
Indian Territory according to the recorded plat  
filed there.

TO HAVE AND TO HOLD the same unto the said A. P. Cooper and unto his heirs  
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said A. P. Cooper that we will forever warrant and de-  
fend the title of said lands against all claims whatever.

And I, Alice M. Mitchell, wife of the said John O. Mitchell for and in consideration of the said sum of  
money, do hereby release and relinquish unto the said A. P. Cooper all right of dower and homestead in and to said lands.
