OFFICIAL FORMWARRANTY DEED  
WITH RELINQUISHMENT OF DOWER.

COMPALED

KNOW ALL MEN BY THESE PRESENTS.

That we John O. Mitchell and Alice M. Mitchell  
his wife, for and in consideration of the sum of One hundred fifty DOLLARS,  
to us paid by W. C. Mundt, the receipt of which is  
herby acknowledged do hereby grant,  
bargain, sell and convey unto said W. C. Mundt and unto his heirs and assigns forever, the following  
lands lying in the Town of West Tulsa Creek Nation Western District of the Indian Territory, to-wit:

all of lots number seven (7) and eight (8)  
in Block number ten (10) situate in West Tulsa Creek  
Nation Indian Territory, according to the recorded plat  
filed thereof.

TO HAVE AND TO HOLD the same unto the said W. C. Mundt and unto his heirs  
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant we with said W. C. Mundt that we will forever warrant and de-  
fend the title of said lands against all claims whatever.

And I, Alice M. Mitchell, wife of the said John O. Mitchell for and in consideration of the said sum of  
money, do hereby release and relinquish unto the said W. C. Mundt all right of dower and homestead in and to said lands.
