

# QUIT CLAIM DEED 5227

WITH RELINQUISHMENT OF DOWER.

THIS INDENTURE, Made this 9 day of July, A.D., 1907 between George H. Bayne and Mabel P. Bayne his wife of Tulsa Indian Territory, Western District, party of the first part, and Nancy J. Williamson of Cedar Rapids, Iowa party of the second part, witnesseth, that the said party of the first part, for and in consideration of the sum of One Dollar dollars,

in hand paid by the said party of the second part (the receipt whereof is hereby acknowledged), has remised, released, sold, conveyed and quit claimed, and by these presents does remise, release, sell, convey and quit claim unto the said party of the second part, heirs and assigns, forever, all the right, title, interest, claim and demand which said party of the first part has in and to the following described lot, piece or parcel of land or improvements, situated in the Creek Nation Indian Territory, Western District, and known and described as follows, to-wit:

Lots Two and three (3), in Block Two (2), in the Friend Addition to the City of Tulsa, Indian Territory.

To have and to hold the same, together with all and singular the appurtenances and privileges thereunto belonging or appertaining, and all the estate, right, title, interest and claim whatever of the said party of the first part either in law or equity to the only proper use, benefit and behoof of the said party of the second part, heirs and assigns, forever.

And I, Mabel P. Bayne wife of the said George H. Bayne

for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part

all my rights of dower and homestead in and to the said lands on which whereof the said George H. Bayne and Mabel P. Bayne herewith set their hands and seals this 9 day of July, 1907.
