WITH RELINQUISHMENT OF DOWER.

THIS INDENTURE, Made this 15th day of October A.D., 1907 between J. M. Gillette and Minnie M. Gillette his wife of Tulsa Indian Territory, western District, party of the first part, and P. L. Price and F. M. Mathewson of Tulsa party of the second part, witnesseth, that the said party of the first part, for and in consideration of the sum of One 00 dollars,

in hand paid by the said party of the second part (the receipt whereof is hereby acknowledged), has remised, released, sold, conveyed and quit claimed, and by these presents does remise, release, sell, convey and quit claim unto the said party of the second part, h/s heirs and assigns, forever, all the right, title, interest, claim and demand which said party of the first part has in and to the following described lot, piece or parcel of land or improvements, situated in the Creek Nation Indian Territory, western District, and known and described as follows, to-wit:

The south-east quarter of the south-east quarter of Section four (4) Township eighteen (18) north Range Twelve (12) east of the Indian base and meridian according to the United States Survey thereof.

To have and to hold the same, together with all and singular the appurtenances and privileges thereunto belonging or appertaining, and all the estate, right, title, interest and claim whatever of the said party of the first part either in law or equity to the only proper use, benefit and behoof of the said party of the second part, h/s heirs and assigns, forever.

And I, Minnie M. Gillette wife of the said J. M. Gillette

for and in consideration of the said sum of money, do hereby release and relinquish unto the said P. L. Price and F. M. Mathewson all my rights of dower and homestead in and to the said lands.
