OFFICIAL FORMWARRANTY DEED  
WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That ye Annie Orcutt Goswin and her  
 his wife, for and in consideration of the sum of Twelve hundred & Ninety (\$1290.00) DOLLARS,  
Cash in hand paid, the receipt of which is hereby acknowledged and  
confessed, do hereby grant,  
 bargain, sell and convey unto said Ruben F. Morley and Augusta M. Morley and unto their heirs and assigns forever, the following  
 lands lying in the Creek Nation Western District of the Indian Territory, to-wit:

said land being my allotment of surplus lands as a citizen of the  
Creek Nation and being my sole and separate property, and are des-  
cribed as follows: to-wit: The South one half (1/2) of the South West quarter (SW 1/4)  
and the South East quarter (SE 1/4) of the South West quarter (SW 1/4) of section eight (8) town  
ship thirteen (13) North Range thirteen (13) East, according to the official plat  
thereof, containing 12 1/2 acres more or less, subject to a mortgage for the  
sum of \$1350.00 in favor of J. H. Clapp.

TO HAVE AND TO HOLD the same unto the said Ruben F. Morley and Augusta M. Morley in the manner aforesaid  
 and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said Ruben F. Morley and Augusta M. Morley that I will forever warrant and de-  
 fend the title of said lands against all claims whatever.

Except above mentioned mortgage

And I, wife of the said Ruben F. Morley for and in consideration of the said sum of  
 money, do hereby release and relinquish unto the said Ruben F. Morley and Augusta M. Morley all right of dower and homestead in and to said lands.
