WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS.

That we J. M. Hall, and Jennie S. Hall, his wife, and M. Gillette and Minnie M. Gillette, his wife,
and J. M. Hocker, and Carrie G. Hocker, One hundred twenty five DOLLARS,
his wife, for and in consideration of the sum of
cash has been paid by V. V. Vandever the receipt of which is hereby
acknowledged,

do hereby grant,
bargain, sell and convey unto said V. V. Vandever, and unto his heirs and assigns forever, the following
lands lying in the Creek Nation Western District of the Indian Territory, to-wit:

Lot 14 in Block 12 in the Gillette Hall addition to the City of Tulsa,
I. T. according to the recorded plat thereof
subject to an oil and gas lease in favor of G. B. Stephens or his
assigns.

TO HAVE AND TO HOLD the same unto the said V. V. Vandever and unto his heirs
and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said V. V. Vandever that we will forever warrant and de-
fend the title of said lands against all claims whatever.

We Jennie S. Hall, wife of said J. M. Hall, Minnie M. Gillette, wife of J. M. Gillette and
and, Carrie G. Hocker, wife of said J. M. Hocker for and in consideration of the said sum of
money, do hereby release and relinquish unto the said V. V. Vandever all right of dower and homestead in and to said lands.
