WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS:

That we F. Marchle & M. T. Self his wife and M. T. Self & Eliza Self his wife
his wife, for and in consideration of the sum of Sixty one and 7/10 DOLLARS,
each in hand paid by H.B. Adair of Marion Ind. Ter., the receipt
of which is hereby acknowledged, do hereby grant,
bargain, sell and convey unto said H.B. Adair and unto her heirs and assigns forever, the following
lands lying in the Creek Nation, Western District of the Indian Territory, to-wit:

Lot no. five (5) in block no. two (2) townsite of
Glenn Pool Ind. Ter.

To have and to hold the same unto the said H.B. Adair and unto her heirs and as-
signs forever, with all appurtenances thereunto belonging.

And hereby covenant with said H.B. Adair that they will forever warrant and defend the
title of said lands against all claims whatever.

And we F. Marchle & Eliza Self, wife of the said F. Marchle & M. T. Self for and in consideration of the said sum of
money, do hereby release and relinquish unto the said H.B. Adair all rights of dower and homestead in and to the said lands.
