WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS:

That we *F. Marchel & J. Marchel, his wife* and *M. T. Self & Eliza Self*
 his wife, for and in consideration of the sum of *Twenty-five* DOLLARS,
cash in hand paid by J. W. Chambers of Mounds, I.T. the receipt
of which is hereby acknowledged do hereby grant,
 bargain, sell and convey unto said *J. W. Chambers* and unto *his* heirs and assigns forever, the following

lands lying in the *Creek* Western District of the Indian Territory, to-wit:
Lots No. seventeen (17) and eighteen (18) in block No. six (6)
located of Glenn Pool Ind. Ter.

To have and to hold the same unto the said *J. W. Chambers* and unto *his* heirs and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant with said *J. W. Chambers* that *they* will forever warrant and defend the title of said lands against all claims whatever, *except oil & gas lease now outstanding against said land*

And we, *J. Marchel & Eliza Self*, wives of the said *F. Marchel & M. T. Self* for and in consideration of the said sum of money, do hereby release and relinquish unto the said *J. W. Chambers* all rights of dower and homestead in and to the said lands.
