WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

COMPARED

KNOW ALL MEN BY THESE PRESENTS:

That we, John O. Mitchell and Alice M. Mitchell
 his wife, for and in consideration of the sum of Two hundred twenty-five DOLLARS,
to us in hand paid by George W. Corby, the receipt of which
is hereby acknowledged do hereby grant,

bargain, sell and convey unto said George W. Corby and unto his heirs and assigns forever, the following
 lands lying in the town of West Tulsa, Creek Western District of the Indian Territory, to-wit:

all of lots numbered one (1) and two (2) in block number twenty
seven (27) situate in West Tulsa Creek Section, Indian Territory
according to the recorded plat filed thereof

To have and to hold the same unto the said George W. Corby and unto his heirs and as-
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant we with said George W. Corby that we will forever warrant and defend the
 title of said lands against all claims whatever.

And I, Alice M. Mitchell, wife of the said John O. Mitchell for and in consideration of the said sum of
 money, do hereby release and relinquish unto the said George W. Corby all rights of dower and homestead in and to the said lands.
