WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS:

That we S. H. Williams and Bessie L. Williams
 his wife, for and in consideration of the sum of Twelve 5/100 DOLLARS,
to and paid by W. W. White

do hereby grant,
 bargain, sell and convey unto said W. W. White and unto his heirs and assigns forever, the following
 lands lying in the 1/4 of the NW 1/4 of the white half (shown) on the red survey as lots 1 & 2 of the NW 1/4 of Sec. 31, T. 19 N., and range 14 E. Creek Nation
Western District of the Indian Territory, to-wit:
Lot 2, no two block 15 no fifteen in Valley S. T.

To have and to hold the same unto the said W. W. White and unto his heirs and as-
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant with said W. W. White that we will forever warrant and defend the
 title of said lands against all claims whatever.

And I, Bessie L. Williams, wife of the said S. H. Williams for and in consideration of the said sum of
 money, do hereby release and relinquish unto the said W. W. White all rights of dower and homestead in and to the said lands.
