do hereby grant,

bargain, sell and convey unto said Martha J. Hammond and unto her heirs and assigns forever, the following lands lying in the Moore Addition to West Creek Nation Western District of the Indian Territory, to-wit:

all of Lots numbered Fourteen (14) and Fifteen (15) in Block number Four (4) situate in Moore Addition to West Tulsa Creek Nation, Indian Territory, according to the recorded plat filed thereof.

To have and to hold the same unto the said Martha J. Hannon and unto her heirs and assigns forever, with all appurtenances thereunto belonging.

And hereby covenant we with said Martha J. Hammon that we will forever warrant and defend the title of said lands against all claims whatever.

And I, Alice M. Mitchell, wife of the said John S. Mitchell for and in consideration of the said sum of

money, do hereby release and relinquish unto the said Martha J. Hannon ^{our} all rights of dower and homestead in and to the said lands.
