WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS:

That we Edan T. Fischer and Maggie C. Fischer
 his wife, for and in consideration of the sum of Four hundred (\$400.00) DOLLARS,
The receipt of which is hereby acknowledged

do hereby grant,
 bargain, sell and convey unto said C. E. Shady and Nora V. Shady and unto their heirs and assigns forever, the following
 lands lying in the Creek Nation Western District of the Indian Territory, to-wit:

all of lots four (4) and five (5) in block thirty five (35) in the original plat
of West Tulsa 2.T. according to the official plat thereof filed in the office of
the Recorder at Tulsa 2.T.

To have and to hold the same unto the said C. E. Shady and Nora V. Shady and unto their heirs and as-
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant S. with said C. E. Shady and Nora V. Shady that they will forever warrant and defend the
 title of said lands against all claims whatever.

And I, Maggie C. Fischer, wife of the said Edan T. Fischer for and in consideration of the said sum of
 money, do hereby release and relinquish unto the said C. E. Shady and Nora V. Shady all rights of dower and homestead in and to the said lands.
