WARRANTY DEED

WITH RELINQUISHMENT OF DOWER.

KNOW ALL MEN BY THESE PRESENTS:

That we John O. Mitchell and Alice M. Mitchell
 his wife, for and in consideration of the sum of Three Hundred thirty five and no/100 DOLLARS,
to us in hand paid by H. W. Fisch, receipt of which is hereby
acknowledged. do hereby grant,
 bargain, sell and convey unto said H. W. Fisch and unto his heirs and assigns forever, the following
 lands lying in the town of West Tulsa Creek, Nation Western District of the Indian Territory, to-wit:

All lots numbered thirteen (13) and fourteen (14)
in block number twenty nine (29); all lots numbered five (5)
and six (6) in block number twenty seven (27) situate in West
Tulsa Creek Nation, Indian Territory, according to the recorded
plat thereof.

To have and to hold the same unto the said H. W. Fisch and unto his heirs and as-
 signs forever, with all appurtenances thereunto belonging.

And hereby covenant with said H. W. Fisch that we will forever warrant and defend the
 title of said lands against all claims whatever.

And I, Alice M. Mitchell, wife of the said John O. Mitchell for and in consideration of the said sum of
 money, do hereby release and relinquish unto the said H. W. Fisch all rights of dower and homestead in and to the said lands.
