## GENERAL WARRANTY DEED

WITH RELINQUISHMENT OF DOWER

Wife's separate property

THIS INDENTURE, Made and entered into this 9th day of August one thousand nine hundred and seven by and between Mellie W. Thompson nee Horn of Broken Arrow, I.T. of the first part, and Carl E. Page of Broken Arrow, I.T. party of the second part.

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Sixteen Hundred and no/100 DOLLARS, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto the said party of the second part the following described real estate and

premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit: The north west quarter of W (14) of the south west quarter of N (14) of section twenty three (23) Township eighteen (18) North Range 14 East of the Indian Base Meridian in the Indian Territory containing Forty (40) acres more or less

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in anywise appertaining thereto.

To have and to hold the aforegranted premises to the said Carl E. Page and his heirs and successors, in fee simple forever; and Mellie W. Thompson nee Horn for herself and her heirs, executors and administrators do covenant with the said Carl E. Page and his heirs, successors and assigns, that we lawfully seized in fee of the aforegranted premises; that they are free from all incumbrance; that we have good right to sell and convey the same to said Carl E. Page as aforesaid; and that we will and our successors, heirs, executors and administrators shall warrant and defend the same to the said Carl E. Page and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, Mellie W. Thompson nee Horn of Broken Arrow, I.T. wife of said Carl E. Page, for and in consideration of the said sum of money, do hereby release and relinquish unto the said party of the second part all my right of dower and homestead in and to the said lands.
