# GENERAL WARRANTY DEED WITH RELINQUISHMENT OF DOWER.

THIS INDENTURE, Made and entered into this 27<sup>th</sup> day of September one thousand nine hundred and seven by and between Garrett Company party of or Brush hill part of the first part, and M. C. Black of Muskogee I.T. of the second part.

WITNESSETH, That the said part y of the first part, for and in consideration of the sum of 500.00 Five Hundred 00/100 DOLLARS, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto the said part y of the second part the following described real estate and premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit:

Last one half of the south east quarter of Section  
(3) three township nineteen (19) north range (3)  
east containing 80 ac. according to U.S. Survey  
ment thereof

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in anywise appertaining thereto.

To have and to hold the aforegranted premises to the said M. C. Black and his heirs and successors, in fee simple forever; and I the said Garrett Company for myself and heirs, executors and administrators do covenant with the said M. C. Black and his heirs, successors and assigns, that I am lawfully seized in fee of the aforegranted premises; that they are free from all incumbrance; that I have good right to sell and convey the same to said M. C. Black as aforesaid; and that I will and my successors, heirs, executors and administrators shall warrant and defend the same to the said M. C. Black and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, wife of said, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part y of the second part all my right of dower and homestead in and to the said lands.
