

GENERAL WARRANTY DEED WITH RELINQUISHMENT OF DOWER.

THIS INDENTURE, Made and entered into this 27th day of September one thousand nine hundred and seven by and between Dick Arch a single man and John Arch and Eyni Arch his wife of Braggs I.T. parties of the first part, and to C. C. Sigler

of part 4 of the second part.
WITNESSETH, That the said part 1st of the first part, for and in consideration of the sum of Three Hundred eighty nine and no/100 DOLLARS, in hand paid, the receipt of which is hereby ac-

knowledge, do hereby grant, bargain, sell, convey and confirm unto the said part 4 of the second part the following described real estate and premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit: The north 4.74 acres of the north west 9.74 acres of Lot two (2) of section 2 and the west half of the northeast quarter of the southeast quarter of the southeast quarter of section 3 Township 18 north Range 13 east of the Indian Base and Meridian being part of the allotment of Hoke Arch deceased.

together with all the improvements thereon, and the appurtenances thereunto belonging or in anywise appertaining thereto.

To have and to hold the aforegranted premises to the said C. C. Sigler and his heirs and successors, in fee simple forever; and the said Dick Arch and John Arch for themselves and their heirs, executors and administrators do covenant with the said C. C. Sigler and his heirs, successors and assigns, that they lawfully seized in fee of the aforegrant- ed premises; that they are free from all incumbrance; that they have good right to sell and convey the same to said C. C. Sigler and his heirs, successors and assigns, that they will and their successors, heirs, executors and administrators shall warrant and defend the same to the said C. C. Sigler and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, Eyni Arch of Braggs I.T. wife of said John Arch, for and in consideration of the said sum of money, do hereby re- lease and relinquish unto the said part 4 of the second part all my right of dower and homestead in and to the said lands.
