

GENERAL WARRANTY DEED WITH RELINQUISHMENT OF DOWER.

THIS INDENTURE, Made and entered into this 9th day of November one thousand nine hundred and five by and between W. T. Huchabay and Martha C. Huchabay of Broken Arrow, Ind. Ter. part 1st of the first part, and George L. Ash of Broken Arrow, Ind. Ter. part 2d of the second part.

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Eight Hundred fifty \$ DOLLARS, in hand paid, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto the said part 2d of the second part the following described real estate and premises situated in the Muskogee or Creek Nation, and within the limits of the Indian Territory, to-wit:

Lot number seven in block number forty three in the town of Broken Arrow, Indian Territory

together with all the improvements thereon, and the appurtenances and immunities thereunto belonging or in anywise appertaining thereto.

To have and to hold the aforegranted premises to the said George L. Ash and his heirs and successors, in fee simple forever; and we the said W. T. Huchabay and Martha C. Huchabay for ourselves and our heirs, executors and administrators do covenant with the said George L. Ash and his heirs, successors and assigns, that we lawfully seized in fee of the aforegranted premises; that they are free from all incumbrance; that we have good right to sell and convey the same to said George L. Ash as aforesaid; and that we will and our successors, heirs, executors and administrators shall warrant and defend the same to the said George L. Ash and his heirs, successors and assigns forever against the lawful claims and demands of all persons.

And I, Martha C. Huchabay of Broken Arrow, Ind. Ter. wife of said W. T. Huchabay, for and in consideration of the said sum of money, do hereby release and relinquish unto the said part 2d of the second part all my right of dower and homestead in and to the said lands.
