

KNOW YE ALL MEN BY THESE PRESENTS, That I Johnnie Rogers  
a citizen of the Creek Nation, and a resident of Keystone Oklahoma  
Indian Territory, for and in consideration of the sum of \$1.00 and other good and valuable considerations to me paid by  
the Mannford Land Company, a corporation, of Muskogee, Indian Terri-  
tory, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and confirm unto the said  
Mannford Land Company, its successors and assigns forever, the fol-  
lowing described lot or parcel of land, lying and being situate in the Creek Nation in Indian Territory, to-wit:

The south half of the south west quarter of section  
twenty (20), and the north west quarter of the  
northeast quarter of section twenty nine (29) town-  
ship nineteen (19) north and Range eleven (11) east

TO HAVE TO HOLD THE AFOREMENTIONED PREMISES unto the said Mannford Land  
Company its successors and assigns in fee simple forever, with all appurtenances thereunto  
belonging, and I, Johnnie Rogers my heirs and assigns, hereby covenants with the said  
Mannford Land Company that said lands are free from all incumbrances, and that  
I, my heirs and assigns will forever warrant and defend the title to said lands against all lawful claims whatever.  
And Johnnie Rogers wife of the said Johnnie Rogers  
for the consideration aforementioned do hereby release unto the said Mannford Land Company  
all my right of Dower and Homestead in and to said lands.
