Mortgage.

This Indenture made this 23d day of December, A. D. 1905, by and between The Baird Land Company, a Corporation duly organized and existing under and by virtue of the laws of the Indian Territory, and doing business in the City of Tulsa, Indian Territory, party of the first part; and The First National Bank, (a corporation) duly organized and existing under and by virtue of the Banking laws of the United States, and doing business in the City of Tulsa, Indian Territory, party of the second part.

Witnesseth: Whereas, the said The Baird Land Company, (a corporation) is justly indebted to The First National Bank of Tulsa, Indian Territory, which debt is evidenced by three (3) promissory notes bearing even date herewith and due on the 23 day of April, A. D. 1906,

Now Therefore, The said The Baird Land Company (a corporation) for the better securing the payment of the money evidenced by the notes aforesaid, with interest thereon according to the tenor and effect of said notes, does hereby grant, bargain, sell and convey unto the said The First National Bank of Tulsa, Indian Territory, its successors and assigns forever, the following described real estate, lying and situate in the Cherokee Nation Northern District of Indian Territory, to-wit:

Lot No. Four (4) of Section Fifteen (15), and the Southwest quarter (1/4) of the North-west quarter (1/4) of Section Fifteen (15), all in Township Twenty-nine (29) North, Range Nineteen (19) East.

The South one-half (1/2) of the South-west quarter (1/4) of the South-west quarter (1/4) of Section Ten (10) and the North-west quarter (1/4) of the North-west (1/4) of Section Fifteen (15) all in Township Twenty-six (26) North and Range Thirteen (13) East.
